4 Actions from Previous minutes

- 4.1 Club constitution has been lodged, approved and took effect from 12th July 2018, President thanked all past committee members for their efforts in getting this passed.
- 4.2 Funds from the Sale of Kingswood are \$5,384.07 after all costs were paid. The Club received three suggestions from members on how to utilize the monies from the sale. One was to hold the funds in a Term Deposit and to hold an annual Ross Booth Memorial Run with the interest accrued. The other two suggestions were both to donate the monies to the charity that the Holden Car Club has always supported AABIC (Association for the Advancement of Brain Injured Children). After a lot of discussion the committee feels that the best and simplest or easiest option for the club would be to donate the funds to AABIC, as the Banks interest rates would not raise large amount of interest. Also we could be setting a precedent, as in the future we could possibly end up having numerous Memorial Runs, if left other bequests. A Committee member would have to take on the extra task of shopping for the best Term Deposit Rate each time it came up for renewal, as well as track all interest earned. Therefore a lot more record keeping. The Holden Car Club is a social club for the enjoyment of all members and the committee would like to keep things simple. Therefore a vote was called, 18 for AABIC and 6 for a Term Deposit and a Memorial Run – motion carried for donation. President will get a representative from AABIC to attend the next general meeting for presentation to be made.
